This conference is held every year for state presidents and organizers. We were given wonderful tools to share on a variety of topics ranging from Goal Setting to Time Management. The following awards were presented to us, but the honor goes to all of you. Keep up the amazing work, we truly appreciate you and your efforts!

"Peak Performers" Award - positive membership growth in 2014 - 2015 year: only 16 awards were given in this category!

"You're A Shining Star" Award - positive membership growth for at least five consecutive years: only 4 awards were given in this category!!

"Making a Difference" Award - organizing at least one new chapter in 2014-2015: Texas was 1 of 2 states organizing 3 new chapters this past year!

"Shooting Star" Award - organized at least one chapter in four of the last five years: Texas has organized 14 new chapters during this period which is more than double anyone else!

"Hooray" Award - no disbanded chapters in 2014-2015: Awesome!!!

"Achievement/Make a Difference (maple leaf)" Award- increase in number of Reinstatements: Texas received the gift of 151 reinstated members, which is more than double when compared to the previous year!!!

If the sister is out of state, please send a Notice of Member in Your Area to the Organizer of that state and to chapter presidents in that sister's new town/city. Chapter presidents' contact information can be found on the International Website under Directory of Presidents.

If an unaffiliated sister needs help locating a chapter either in or out of state, have her contact me, Missy Kittner, missykittner@yahoo.com, and I will work with her to find a chapter.

Unaffiliate members who do not connect with a chapter in two years are more likely to fall out of the P.E.O. habit and eventually go inactive...something we all want to prevent. The TSOFI Board thanks all of the P.E.O. chapters and individuals for their generosity during the past P.E.O. year. The board was able to award 31 grants totaling almost \$139,000 to Texans in need. These applicants have benefited greatly from your generosity, and the grants have helped to better their lives and lessen a financial burden.

TSOFI grant applicants must meet the following requirements:

- ★ Texas resident
- * US citizen
- ★ In dire financial need of an amount of money that cannot be obtained from another source
- ★ Without substantial savings, assets, or income

Typical grants are for dental and vision expenses, childcare, car repairs, medical expenses, and even educational assistance. Potential applicants can be found anywhere - church, hair salons, and non-profits where P.E.O. sisters serve, and more! Please keep your eyes and ears open! P.E.O. International Peace Scholarship Fund (IPS)

Where the Dreams and Hopes of the world meet the generosity of P.E.O.s

The International Peace Scholarship Fund, established in 1949, provides scholarships of up to \$10,000 for women from around the world for graduate

study in the United States and Canada.

There are two ways your chapter can support an IPS student:

- 1. Help international graduate students learn about IPS. Visit the international graduate student office at a nearby college and/or post an IPS flyer on their bulletin board. If you know of a student who may qualify, refer her to the International website where she can complete an eligibility form between September 15th and December 15th.
- 2. **Become a Partners in Peace Chapter.** A chapter(s) who contributes at least \$500 and completes a Partners in Peace form will not only help to fund IPS scholarships, but will be able to partner with an IPS recipient. Chapters completing this process prior to March 1, 2016 will be assigned an IPS student for the 2016-17 academic year.

Since its inception, IPS has helped more than 6,000 women in 168 countries attain their educational goals. This year, the IPS Board of Trustees awarded 184 scholarships to women from 75 countries, in the amount of \$1,606,350.00. Information on IPS students studying in Texas will be available this fall.

Dear Daisy: My Chapter would like to invite a P.E.O. to transfer to our chapter, but we don't have another business meeting scheduled until September. May we vote on inviting her during a Social Meeting, since we will have three of those this summer and most of our members attend the socials?

Answer: No, I am afraid you may not conduct <u>any</u> business during a Social Meeting. Also, membership issues such as voting to extend an invitation to membership or an invitation to transfer may not be conducted at a Special Called Meeting. (The list of <u>business not to be conducted</u> during a Special Called Meeting is found in the Presidents' Book, Appendix #2.) The vote to extend an invitation to transfer must be done during a regular business meeting.

Please do invite the prospective transferring member to all of your summer socials where members will enjoy getting to know her.
